<p>The Transcend Level 4 Certificate in International Armed Close Protection is an Ofqual regulated occupational qualification. <p>Qualification rationale</p>	<p>Across Great Britain, 2.03 million people reported that they had previously served in the UK armed forces (76% in the regular forces, 20% in the reserve forces and 4% in both). This represents 3.8% (almost 1 in 25) of the total population aged 16 or over. Overall, 7.0% of households in Great Britain included one or more veterans. To enable veterans to thrive in their transition into civilian life they need to demonstrate occupational competence in civilian roles.</p> <p>The Transcend BTB MVP Education Portfolio is comprised of progressive suites of qualifications that are regulated by Ofqual.
